DO YOU SEE YOURSELF AS A SOVEREIGN INDIVIDUAL IN AMERICA? OR DO YOU SEE YOURSELF AS A POWER-LESS PAWN IN THE SOCIAL ENGINEERING ARENA THAT IS RUN BY THE RICH AND POWERFUL?

- 2. To what extent do you think corruption in government contributes to the high costs of education, health care, national defense and security, infrastructure maintenance, humanitarian initiatives, housing, and even costs of day-to-day living?
- 3. How many people do you know, including yourself, that you believe could do a better job than the average member of the U.S. Congress is currently doing?

I can, readily, name dozens of people that could do a better job - and I believe a growing number of frustrated Americans feel the same way. Unfortunately, the proliferation of "arbitrary rule" (please refer to Vol. 6 No. 1 of The Due Process Advocate) by and through the self-serving efforts of the social engineers working for the powers-to-be, make it extremely difficult for newcomers to participate in the legislative process at high levels (unless, as we all know, they have access a lot of resources and money available to mount a successful election campaign).
