

## Age of Majority Survey

### **Preliminary Information**

*Thank you in advance for your participation in this ongoing survey to receive your recommendations and rationale about what age a student should become an adult under the law. No doubt you are aware of the ever-increasing liabilities that are accruing to students, parents, teachers, administrators, and law-enforcement agencies that involve actions and behavior that are governed, in whole or part, by age of majority laws in the jurisdiction where a student is attending a public or private school.

The age of majority is defined as the age at which a minor legally becomes an adult in the United States. In most states, the age of majority is 18. Reaching the age of majority means that a student acquires critical rights (and responsibilities) such as the right to vote, the right to join the military, the right to enter into a legally enforceable contract, the right to consent to or receive certain medical treatments, and much, much more. At law, however, certain rights are restricted or denied at the age of majority. Depending on jurisdiction, these restricted rights include the right to buy or consume alcoholic beverages, buying and using firearms, going into a nightclub, booking a hotel room, or gambling in a casino. In view of these restricted rights, there is considerable disagreement as to whether the age of majority should remain at 18 as it is in a vast majority of states across the country.

This survey is being conducted to obtain your personal opinion, feedback, and comments regarding the age of majority.
