Almost immediately, DPA evolved into a support organization for subscribers and clients who had personally experienced the devastating effects of "arbitrary rule" (i.e. judges and hearing officers making decisions based on their personal views instead of the law) that was becoming commonplace in many courts and government agencies. As a result, DPA's business mission rapidly expanded to provide access to a host of resources designed to help its members protect and assert their due process rights in a wide variety of legal issues, problems, and actions.
